
### Monthly Trends for Selected Notifiable Infectious Diseases As of December 20, 2014




#### Incidence of Campylobacteriosis by Month




#### Incidence of Giardiasis by Month



#### Incidence of Pertussis by Month




#### Incidence of Salmonellosis by Month




