# NEW MEXICO INFLUENZA SURVEILLANCE UPDATE Summer 2009

Week Ending	Activity Level
8/8/09 (MMWR Week 31)	Sporadic

<sup>&</sup>quot;Sporadic" activity is defined by the Centers for Disease Control and Prevention as influenza-like illness (ILI) activity not increased in the regions AND isolated lab-confirmed cases.

Summary of State-wide viral test samples (PCR and cultures) submitted to the Scientific Lab Division (SLD) from late April - July 27, 2009 (Current period of influenza surveillance activity) 1:

### Summary of Influenza Outpatient Surveillance in NM for Week Ending 8/8/091:

Twenty of the 22 sites reporting:

- total of 5,809 patient visits seen for any reason,
- 41 (0.7%%) were positive for influenza-like illness (ILI)<sup>2</sup>, and
- previous week (ending August 1st) reported 1.0% influenza-like illness.

Note: The sensitivity and specificity of point of care rapid diagnostic tests vary during times when influenza is not circulating widely. The NM Influenza Surveillance Program expects some false positive rapid diagnostic results outside the time of peak influenza activity (i.e., beginning and end of season). The first NM laboratory confirmed case of the influenza season is based on a positive viral culture result.

Weekly ILI and lab data may change as additional reports are compiled.

<sup>&</sup>lt;sup>2</sup> Influenza-like Activity (ILI) is defined as Fever (≥ 100°F [37.8° C], oral or equivalent) AND cough and/or sore throat in absence of a KNOWN cause other than influenza.

<sup>&</sup>lt;sup>3</sup> Some rapid influenza tests cannot differentiate between types A and B.

#### **Pediatric Influenza-Related Mortality:**

Since October 2008 to present, a total of 101 pediatric deaths have been reported to CDC in this season, 33 of which were due to novel influenza A (H1N1) virus infections. There have been no influenza-related pediatric deaths reported in New Mexico during that time period.
