

HIV/AIDS by Regions of New Mexico

Regional HIV/AIDS data is essential for local prevention and planning efforts. Only July 1, 2005, the New Mexico Department of Health (NMDOH) re-configured the state into 5 public health regions (Figure 1). These regions reflect each quadrant of the state and Bernalillo County. This report examines the regional distribution incident. prevalent. and of cumulative HIV/AIDS cases diagnosed in New Mexico. Incident cases are defined as newly diagnosed cases of HIV or AIDS, and excludes cases that were previously identified as HIV and have become AIDS. Prevalent cases are those currently known to be living. Cumulative cases are the total cases reported to NMDOH since 1981 for AIDS and 1998 for HIV.

Region 1

This region covers the northwestern quadrant of New Mexico. Region 1 includes a large part of the Navajo Nation, whose Native Americans make up 33% of the region's population. This part of the state has the largest number and proportion of Native Americans with HIV/AIDS. population in Region 1, they have the highest incidence rate (16.9 per 100,000). Cibola County has the highest incidence rate among all Region 1 counties (Table 1), though this may reflect enhanced testing at prison facilities located there.

Region 2

The northeastern part of New Mexico, which includes Santa Fe County, is covered in Region 2. Much of this region is considered rural, and has a predominantly Hispanic population (48%). Though Region 2 reports few new HIV/AIDS cases each year, Santa Fe County has always had a disproportionately high number of living cases (Table 2). Santa Fe County has the highest prevalence in the state at 313.8 per 100,000 persons. While incidence across the state has risen since 2001, new cases in Region 2 have remained relatively stable.

Region 3

Region 3 is Bernalillo County, which includes Albuquerque, the largest city in the state. Approximately 1/3 of the state's population resides here. About 41% of all new cases in the state occur in Bernalillo County which has the second highest prevalence rate of 178.1 per 100,000. The distribution of cases in Region 3 is representative of the all HIV/AIDS cases in New Mexico (Table 3). The increasing trend in new HIV/AIDS cases is most recognizable in Region 3, and has been characterized by a larger proportion of cases occurring in younger age groups (20-29 years).

Region 4

The southeastern part of New Mexico is relatively rural compared to much of the rest of the state. Its border with the state of Texas influences cases in Region 4; out-of-state cases often receive services in New Mexico, and viceversa. Overall, the region reports few new cases each year and has the lowest burden in the state (Table 4). New HIV/AIDS cases that have been reported in recent years have also been seen in younger age groups.

Region 5

This region includes the city of Las Cruces, the second largest city in New Mexico. Las Cruces lies within the metropolitan area of Ciudad Juárez, Mexico and El Paso, Texas. As a result of these borders, the population in Region 5 is relatively mobile and, often, leads bi-national lives. As much as 52% of the population in Region 5 is Hispanic. The region also has a higher number of new HIV/AIDS cases among Hispanics (Table 5). This part of the state has one of the highest proportions of concurrent diagnoses of HIV and AIDS (see Summer 2004 Quarterly Report). Such cases present with more advanced service needs and may serve as a proxy for targeted HIV/AIDS efforts. As in Region 3, incidence in this part of the state has also been on the rise.

HIV/AIDS Epidemiology Program Update

New Mexico has a high proportion of HIV/AIDS cases that have been diagnosed out-of-state and are currently residing and/or receiving services in New Mexico. Please note that Quarterly and Special Reports will now include cases from out-of-state in the Fact Sheet on the back page. For the purposes of prevention and services, these data better reflect local prevalence patterns and overall burden.

HIV/AIDS IN NEW MEXICO FACT SHEET

Cases reported through June 30, 2005

In previous reports, the HIV/AIDS Epidemiology Program summarized only cases diagnosed in New Mexico. Living cases diagnosed in New Mexico are used by the U.S. Centers for Disease Control (CDC) to represent prevalent cases. However, data that include out-of-state diagnoses provide a better reflection of local prevalence patterns and are now the basis of the summary.
