

### New Mexico Department of Health 2016 Weekly Infectious Disease Report Week 7 February 14, 2016 - February 20, 2016

NM-EDSS is a web-based system used by public health staff throughout the state to track investigations of suspected, probable and confirmed cases of notifiable infectious diseases. 
### Monthly Trends for Selected Notifiable Infectious Diseases As of February 20, 2016




#### Number of Reported Cases of Campylobacteriosis by Month




#### Number of Reported Cases of Salmonellosis by Month




#### Number of Reported Cases of Giardiasis by Month




#### Number of Reported Cases of Shigellosis by Month
