

### New Mexico Department of Health 2017 Weekly Infectious Disease Report Week 11 March 12, 2017 - March 18, 2017




### **Monthly Trends for Selected Notifiable Infectious Diseases** As of March 18, 2017


#### Number of Reported Cases of Campylobacteriosis by Month




#### Number of Reported Cases of Giardiasis by Month




#### Number of Reported Cases of Pertussis by Month




#### Number of Reported Cases of Salmonellosis by Month
