This report is prepared by the Center for Health Protection (CHP) Infectious Disease Epidemiology Bureau (IDEB) for notifiable infectious diseases reported through the New Mexico Electronic Disease Surveillance Systems (NM-EDSS). NM-EDSS is a web-based system used by public health staff throughout the state to track investigations of suspected, probable and confirmed cases of notifiable infectious diseases. Data for the current year are provisional and subject change upon the completion of ongoing disease investigations. 
Monthly Trends for Selected Notifiable Infectious Diseases As of March 29, 2025






Number of Reported Cases of Campylobacteriosis by Month

Number of Reported Cases of Salmonellosis by Month











Number of Reported Cases of Shigellosis by Month








Number of Reported Cases of Pertussis by Month
