

New Mexico Department of Health 2025 Weekly Infectious Disease Report Week 29 July 13, 2025 - July 19, 2025

This report is prepared by the Center for Health Protection (CHP) Infectious Disease Epidemiology Bureau (IDEB) for notifiable infectious diseases reported through the New Mexico Electronic Disease Surveillance Systems (NM-EDSS). NM-EDSS is a web-based system used by public health staff throughout the state to track investigations of suspected, probable and confirmed cases of notifiable infectious diseases. Data for prior years are also subject to minor revisions due to corrections or identification of historical cases. 
Monthly Trends for Selected Notifiable Infectious Diseases As of July 19, 2025



Number of Reported Cases of Campylobacteriosis by Month



Number of Reported Cases of Giardiasis by Month




Number of Reported Cases of Pertussis by Month





Number of Reported Cases of Salmonellosis by Month


