**To schedule a screening mammogram**

When scheduling:

1. State that the appointment will be under the BCC Program (on referral under "Insurance")
2. Fax/attach the client's BCC Screening Referral Form/Consent along with any other medical information needed to the Cancer Center (include pathology and clinical notes)
3. Fax all of the same patient information to Wendy or Karla (BCC Case Managers) at UNM 505-272-8331.
4. Call Clinic/Pt. line in 2-3 days to make sure the paperwork was received.

To refer a **Breast Surgical Consult** (fibroadenoma increasing in size, radial scar, sclerosing lesion) to UNM Sandoval Regional General Surgery:

1. Fax referral with BCC Screening and Referral Form/Consent, along with medical information to Wendy/Karla at 505-272-8331
2. Call Wendy or Karla in 2-3 days to make sure the paperwork was received

**For Cervical Referrals:**

To refer to UNM under BCC for a **Colposcopy or LEEP** :

1. Fax referral with BCC Screening and Referral Form/Consent to Nadine Torres at 505-272-1109 and fax to Wendy. 505-272-8331. Indicate on cover sheet that patient is BCC. Include test results (plus last year's if necessary)
2. Follow up with Wendy in 1-2 weeks at 505-272-1789 or leave message at 505-272-5446.
