What is a Pediatric Emergency Care Coordinator and why are they important?



definition

A "Pediatric Champion" is Pediatric Emergency Care Coordinator (PECC) who works in a hospital, EMS service or lives in the community and advocates for kids health and well-being.

Who is a Pediatric Champion?

- Anyone who has a passion for children
- Coordinates pediatric-specific activities
- Holds the position full-time or part-time
- Champions for pediatrics as part of their regular job duties or as their only job
- May be a member of one agency and/or represents other agencies, regions, or levels
- Serves to champion pediatric activities with more than one agency
- May be an individual or group of individuals

GROWING PAINS

The Institute of Medicine 2007 publication "Emergency Care for Children: Growing **EMERGENCY CARE** Pains," recommended that EMS agencies "appoint a pediatric emergency coordinator...to provide pediatric leadership for the organization." This recommendation was based on findings that PECCs "are necessary to advocate for improved competencies and the availability of resources for pediatric patients."

The conclusion of the 2017 systematic review is that an "EMS PECC facilitates the integration of pediatric needs into all aspects of EMS," and that EMS agencies may benefit from having a PECC based upon results received from pediatric verification programs for emergency departments.

- Community paramedicine

 □ Identify local
- □ Identify local trends
 □ Research
- □ Identify best practices/ evidence-based medicine
