- Minutes Approval (Katrina)- Unanimously Approved
- Board member update (Katrina)
 - Need Consumer Member to replace Carrie; Katrina will reach out to Carrie to see if she has any suggestions
 - Questionable new vetting process (ie does it need to be done at all with new governor) – will know more by next meeting
- Rule Changes - Update (Katrina/Katie)
 - Hearing was in September 2018, Comments were received, reviewed, approved, and updated. The hearing officer has finished review and final revised rule will be published 6.25.19 in the NM State Record & Archives.
 - No change to scope of practice but wording has been improved to reflect ACNM wording
 - Question on opening of Rule again in 2020 related to Naloxone prescribing – unknown if this will happen at this time.
 - Also, DOH considering creating webinar to educate CNMs about new changes.
- Legislative Update (Abby)
 - No update from Abby
 - Consideration for transgender bill in 2020 legislative session
- AIM (Abby/Katie/Katrina)
 - Alliance for Innovation in Maternal Care
 - NM became an AIM state in February 2019
 - Hemorrhage bundle is the 1st bundle being rolled out. We are using Project ECHO to provide training webinars.
 - Have approximately 6 hospitals signed up, but more are participating on webinars, and hoping more will sign up. (30 birthing hospitals in state).
 - Need more awareness around incentives to facilities for being involved and giving resources to provide data back to AIM
 - Participants receive CEUs for attending
 - NMPC will be receiving \$100,000 from state budget and some of this funding will be used to contract a person to work on recruiting participation from more healthcare facilities.

- BWRP update (Katie)
 - DOH attempted to open the rule to:
 - Add a new provider type – LMs
 - Revise criteria for prioritization of awards
 - One problem with bill was that by adding new provider type, legislators felt that more money should be allotted to fund as well.
 - Plan to introduce bill in 2020 legislature
- CME Audit Plan (Katie)
 - DOH is moving to CE Broker to collect continuing education for renewals to compliment the new online application system
- Online Application Project (Katie)
 - Will be going live July 1 to begin orienting August renewals to the system
- Breastfeeding Task Force (Sophie) - Deferred at this time
