## Agenda items

1. Call to Order and Opening Statements
  - Meeting opened with thirty seconds of silence in recognition of world events
  - Chair Chris Peskuski provided opening remarks
  - Chair emphasized respectful participation and meeting conduct
  
2. Introduction
  - Chris Pekuski introduced himself as a Marine veteran with lived experience related to deployment, traumatic brain injury, PTSD, depression, and recovery
  - Chair shared intent to pursue licensure as a facilitator and support an upcoming UNM veteran's study
  - Participants introduced themselves and shared relevant background, including experience in cultivation, therapy, mycology, advocacy, policy, and research
  
3. Review of Agenda
  - Agenda reviewed
  - No objections noted
  
4. Review of Bylaws
  - Chair requested bylaws be displayed
  - Bylaws were displayed and posted in the chat by DOH staff

- Chair stated expectations regarding disruptive behavior and meeting decorum
- Chair noted meetings will occur biweekly initially
- Chair emphasized preference for consensus while encouraging participants to speak openly

#### Discussion

- Feedback provided regarding inclusion of language addressing disruptive behavior
- Recommendation made to include disclosure of financial or professional conflicts of interest
- Discussion held regarding voting participation, non-New Mexico residents, and press attendance
- DOH staff clarified this committee functions as a work group and recommendations will be forwarded to the Board, where exclusions and voting rules are governed
- Language was added clarifying disclosure of conflicts of interest upon request of the Chair

#### Action

- Chair called for dissent regarding bylaws
- No objections raised
- Bylaws adopted

#### 5. Review of Expanded Propagation Committee Scope of Responsibilities

- Expanded scope posted by DOH staff
- Chair opened the floor for feedback

#### Discussion

- Questions raised regarding limitation to specific psilocybin species and consistency of quality
- DOH staff explained limitations relating to tracking, testing, and quality assurance
- Discussion held regarding cultivation, genetics, taxonomy, harvesting, potency variation, and standardization
- Emphasis placed on safety, traceability, and phased program implementation
- Discussion included potential future consideration of additional species following program launch

- DOH staff clarified initial rules are not static and will evolve through rulemaking and public comment

#### 6. Public Comment and Technical Discussion

- Public comments addressed cultivation methods, genetic tracking, potency variability, testing protocols, and traceability
- Discussion included homogeneity testing, HPLC testing standards, and batch consistency
- Clarification provided that psilocybin products cannot cross state lines under federal law
- Discussion held regarding potential non-medical product development, which is not allowed under statute
- Participants discussed traditional use considerations and different delivery forms
- DOH staff emphasized that initial implementation prioritizes safety and consistency

#### 7. Additional Business

- Discussion held regarding industry participation and importance of subject matter expertise
- Software tools related to genetics, cultivation tracking, and compliance discussed
- Chair expressed interest in holding a future in person meeting
- Participants were informed that recordings and documents will be posted within five to ten business days
