## Revised Therapy Agency QI Plan and Report Templates

- Therapy Agencies are required by the DD Waiver Standards and by provider agreements to submit their agency Quality Improvement (QI) Plan with all provider application packets. Agencies are also required to submit an Annual Therapy Agency QI Report by February 15<sup>th</sup> of each year. In an effort to simplify this process the Clinical Services Bureau (CSB) recently distributed revised templates for Therapy Agency QI Plans and Reports as well as associated instructions. The QI Templates have been updated to meet the more robust QI requirements of the 2018 DD Waiver Standards. Therapy agencies are highly encouraged to use these templates to help simplify the agency's QI reporting, to assure that related DD Waiver Standards are addressed, and to assist DDSD in gathering standardized and relevant QI data related to DDW therapy services.
- Therapy practitioners that work for or are employed by therapy agencies do not have to submit these reports, however, therapy practitioners should be aware of what information will be monitored to provide data related to the quality of your therapy services. Some specific areas that your therapy agency will be monitoring will include the following:
  - Do therapy documents have appropriate contents as outlined by the therapy standards?
  - o Is therapy documentation submitted on time?
  - o Are therapy objectives outlined in the Therapy Intervention Plan (TIP) measurable?
  - o Does the Annual Therapy Re-evaluation identify if therapy objectives worked on during the reporting period were met or if progress had been made?
  - o Do therapy WDSIs have an initial or a reviewed/or revised date indicated yearly?
  - o Have therapy practitioners completed all required training courses?
- ➤ Therapists should consider focusing on therapy objectives that are measurable and that can be met within 12 months or less. Therapy objectives often identify a specific skill or performance parameter that will be increased from baseline. Remember, however, that therapy objectives that are for the DSP, the therapy practitioner themselves, or that are maintenance objectives for the individual are also acceptable. All healthcare systems are placing more emphasis on meeting identified outcomes and on assuring that providers have evidence that services are cost-effective and are providing essential supports that assist those we work with to participate in their communities and to meet vital health and safety needs.
- ➤ Therapy Agencies Thank you so much for your feedback and your time in reviewing and implementing use of these revised QI tools. Therapy Practitioners thanks for being aware of the quality indicators that your agency and DDSD will be monitoring. # Clarification of Use of a "Designated Trainer"

- The Standards require that all WDSI expected to be implemented by DSP must be trained at least annually and this can be completed by a "designated trainer". Further, the ARM standards state that competency-based training is required and that the therapist, including the SLP, may designate training. This could include a small portion of the training, such as which type of utensil to use, or an entire strategy section (saliva management, positioning, medication delivery, etc.).
- ➤ There are SLPs, and other therapists, that do not believe it is appropriate to designate certain individual specific training to non-skilled personnel. This determination is left to the professional judgement of the therapist! It states in the standards that no agency can require that training of a particular set of instructions or WDSI be designated. You may have heard some therapists say that they rarely designate training. That is their prerogative. Therapists tend to have strong opinions about designating training, CARMP training in particular since it is a health and safety issue. The decision of whether to designate or not is individual specific and WDSI or CARMP specific.
- ➤ Please do consider designating a trainer for those WDSI or CARMP areas that may not require a therapist's skill or perspective to train. For situations where a reliable agency staff or family member is willing and able to train and the therapist feels comfortable having someone else train (often instructions that do not have a large health or safety component) having a "designated trainer" can work very well for all concerned.

If more than 58 hours are needed for the therapist to implement the Therapy Intervention Plan, the therapist must submit an "Application for JCM Clinical Exception Form" - available on the Therapy Services website.

Therapy Service Provider Agencies are responsible for entering all information regarding current therapist employees/contractors into the *Statewide Training Database*. Remember also to remove the names of any employees/contractors who are no longer working for your agency! Therapy Service Provider Agencies must make sure that all therapists are current on required therapy trainings. Entering required information into the Statewide Training Database will help ensure that compliance reports for completion of required training reflects correct information about your agency. - A larger number of therapists than expected have not met training requirements as set forth in the DD Waiver Standards. This is especially problematic for the Abuse, Neglect and Exploitation training. The initial ANE training must be a face-to-face training.   The CSB is working with the training unit to make more face-to-face ANE trainings available throughout the state so therapists can more easily meet this requirement.

  Please note that ANE is the only training that is required yearly! After the first face-to-face training, ANE re-certification may be taken on-line.
