MEDICAID SUPPORTS WAIVER UPDATE

DDSD's new Home and Community-Based Services (HCBS) Supports Waiver implementation date, pending approval by the Centers for Medicare and Medicaid Services (CMS,) is rapidly approaching! July 1, 2020 will begin the second phase of the Governor's three-tiered plan for people who are currently on the developmental disabilities waiver waiting list or who are waiting for an allocation to the Developmental Disabilities (DD) or Mi Via Waivers.

Here are a few important points to know about the Supports Waiver:

- Supports Waiver services are intended to complement unpaid supports that are provided to individuals by family and others
- Individuals will be offered the Supports Waiver in groups of up to 2,000 per year, based on registration date, until all individuals on the DDSD Central Registry Wait List have received an offer
- If someone does not accept the Supports Waiver offer, the offer does not close, it is always an option for individuals while on the Wait List for the DD/Mi Via Waivers pending legislative funding

- Individuals will keep their place on the DD Waiver Wait List while they access the Supports Waiver
- Children in pend status are not on the DD Waiver Wait List and therefore will not be offered the Supports Waiver
- The Supports Waiver will offer an agency-based and participant-directed track
- A "Call for Providers" will be issued in March 2020. There will be a "fast track" application process for existing providers who provide services parallel to the services that will be offered on the Supports Waiver, if they meet certain criteria
- If an individual is on the Supports Waiver they will have a Centennial Care Managed Care Organization (MCO). For information on MCO enrollment provisions for Native Americans, please visit: https://www.hsd.state.nm.us/Looking ForAssistance/Native_Americans.aspx.

FAMILY SUPPORTS PROGRAM

Department of Health Launches Family Supports Program Program aids those on Developmental Disabilities Waitlist

The New Mexico Department of Health is mailing applications to about 1,500 residents to provide immediate support for individuals on the waitlist for developmental disabilities support that can help pay for items like eyeglasses, hearing aids or adaptive equipment. Additionally, in collaboration with the Human Services Department, the Department of Health is contacting all individuals on the waitlist to discuss additional resources and services. This includes contacting children (their families) and adults to make sure all individuals in need of services are maximizing their Medicaid benefits. Children on the waitlist, under the age of 21, who are Medicaid eligible, can access services through the Early and Periodic Screening, Diagnostic and Treatment (EPSDT) program. Adults on the waitlist, who are Medicaid eligible, can access services through the New Mexico Community Benefit program.

The Family Supports and Reimbursement Program was created to assist residents on a waiting list for the Developmental Disabilities Waiver. The Developmental Disabilities (DD) Waiver provides funding for home and community-based services for children and adults with developmental disabilities or related conditions. The Medicaid-funded program currently serves about 5.000 developmentally disabled New Mexicans. Another 5,000 are on a waiting list, some for more than a decade. "The goal over the next six years is to overhaul the DD Waiver program to better provide services and eliminate the waitlist entirely," said Department of Health Cabinet Secretary Kathy Kunkel. "We share Governor Michelle Lujan Grisham's commitment to provide the needed services for New Mexicans with developmental disabilities and their families."

For more information contact: Juanita Salas, State General Fund Program Manager The mailing, which also includes program information, is going to about 1,500 residents on the waitlist who may be eligible under the following requirements:

- The applicant must be a New Mexico resident.
- The applicant must be registered with the New Department of Health, Developmental Disabilities Supports Division's Central Registry and placed on the Waiting List.
- The individual must meet New Mexico's state definition for developmental disability as stated in New Mexico Administrative Code (NMAC) 8.290.400.
- The applicant is not eligible for any Medicaid State Plan benefit(s).
- The applicant is or has not received any State General Fund services during the current Fiscal year.

DDSD Community Inclusion Staff Participate in Albuquerque Public Schools Transition Fair and Project Search Parent Information Night in Farmington

Developmental Disabilities Supports Division (DDSD) staff continue to support activities that increase employment and community outcomes for youth in transition who are eligible for DDSD services throughout the state.

Metro Community Inclusion Coordinator, Frank Gaona represented DDSD at the APS Zone 2 Transition Fair hosted at Atrisco Heritage High School on January 30th, 2020. The transition fairs are held to help prepare students and parents for life beyond high school. Attendees at the fair were given the opportunity to learn about community organizations, college admissions, educational and vocational training programs, adult agencies and employers that support people with disabilities.

Farmington Project Search Year 2 Parent's Information Night was held on Feb. 11, 2020 at Farmington Municipal Schools. Six high school interns and their parent/parent representatives were in attendance. Katherine Johnson, NWRO Community Inclusion Coordinator, provided the attendee's information on the DDSD Transition to Employment Grant. The Transition to Employment Grant is designed to provide on-the-job supports and transportation for competitive integrated employment to individuals who have recently exited or are preparing to exit/graduate high school.

Project Search is an internship program for students with disabilities, ages 18-22 that prepares them for competitive integrated employment. During Parents Night, each intern provided a speech about what they have learned so far and how the program has changed their lives. In addition to the host businesses, Project Search steering committee members in attendance included representatives from DDSD, Farmington Public Schools, Division of Vocational Rehabilitation and PMS Project Shield.






