Class Members with Immediate or Special Needs One individual was found to need Immediate Attention.

Individuals for whom urgent health, safety, environment and/or **1 of 14; 7%** abuse/neglect/exploitation issues were identified which the team is not successfully and actively in the process of addressing in a timely fashion.

Two individuals were found to have Special Attention Needs.

Individuals for whom issues have been identified that, if not **2 of 14; 14%** effectively addressed, are likely to become an urgent health and safety concern.

In 2011, one person was found to need Immediate Attention; five people required Special Attention. There were 16 people in the 2010sample.

In 2009, two people were found to need Immediate Attention, and three people required Special Attention. One RORI and one Incident were filed for two different individuals. There were 16 people in the 2009 sample.

In 2007, no one reviewed was found to need Immediate Attention; one person required Special Attention. There were 16 people in the 2007 sample. In 2013, one person was found to need Immediate Attention; one person required Special Attention. There were 15 people in the 2013 sample.

In 2010, one person was found to need Immediate Attention; two people required Special Attention. There were 16 people in the 2010 sample.

In 2008, two people were found to need Immediate Attention, and one person required Special Attention. There were 16 people in the 2008 sample.



Identified Indicators of Good Practice People are active in their communities and have roles/memberships

- □ Six people attend church.
- **Ten** people frequent the library.
- **Two people are regulars at the Bowling Alley**
- Seven people are active at their local recreation/community centers.

Two individuals in the sample had one identified membership or community role (see this and the next slide). Eight people had two, three had three, and one had four identified memberships/roles.



Identified Indicators of Good Practice People are active in their communities and have roles/memberships

- One person is a regular at the zoo.
- **Three people are active volunteers.**
- One person is a member of the Praise Band.
- **One person participates in Reins of Life.**



Some people are a part of and integrated into their communities

- Twelve people have adequate access to and use of generic services and natural supports.
- Nine people were seen as adequately integrated into the community.

Some people have friends

Eleven people have non-paid friends with whom they interact in the community and visit regularly.



Some people benefit from long term, caring and respectful staff

- Three people have residential staff that have been with them for at least five years. One of those have had staff for nineteen years!
- Four people have day staff that have been with them for at least five years.
- □ Thirteen people have case managers who "know" them and can describe their preferences, wants and needs.



Some people have proactive advocates Case Manager/Guardian

- □ Four people were identified as having actively involved guardians. (Seen at least 3 times a month)
- Eleven people have case managers who are adequately available to them.
- Three people have case managers who fully understand their role/job.



Some people have shown evidence of progress

- Eight people are going more places or interacting more while in the community.
- Seven people have shown a decrease in identified behaviors.
- □ Six people have increased their choice making.
- Seven people are becoming more independent in their personal or home care or have increased their work skills.
- □ Six people have increased their communication abilities.



Some people have the technology and devices they need

144 assistive technology and adaptive equipment devices are needed by the individuals in the sample; 140 are in good repair, available, and used when needed. (97%).

- 85% of teams (11 of 13) did not adequately arrange for and obtain the needed, relevant assessments. (87% did not in 2013, 44% in 2011, 50% in 2010, 44% in 2009, 56% in 2008) Q# 58
- 69% of assessments (9 of 13) were not adequate for planning. (87% were not in 2013, 44% in 2011, 2010, 2009 and 2008) Q# 59
- 54% of individuals (7 of 13) had recommendations from assessments that were not adequately used in planning. (67% were not in 2013, 31% in 2011, 44% in 2010, 50% in 2009, 56% in 2008) Q# 60








