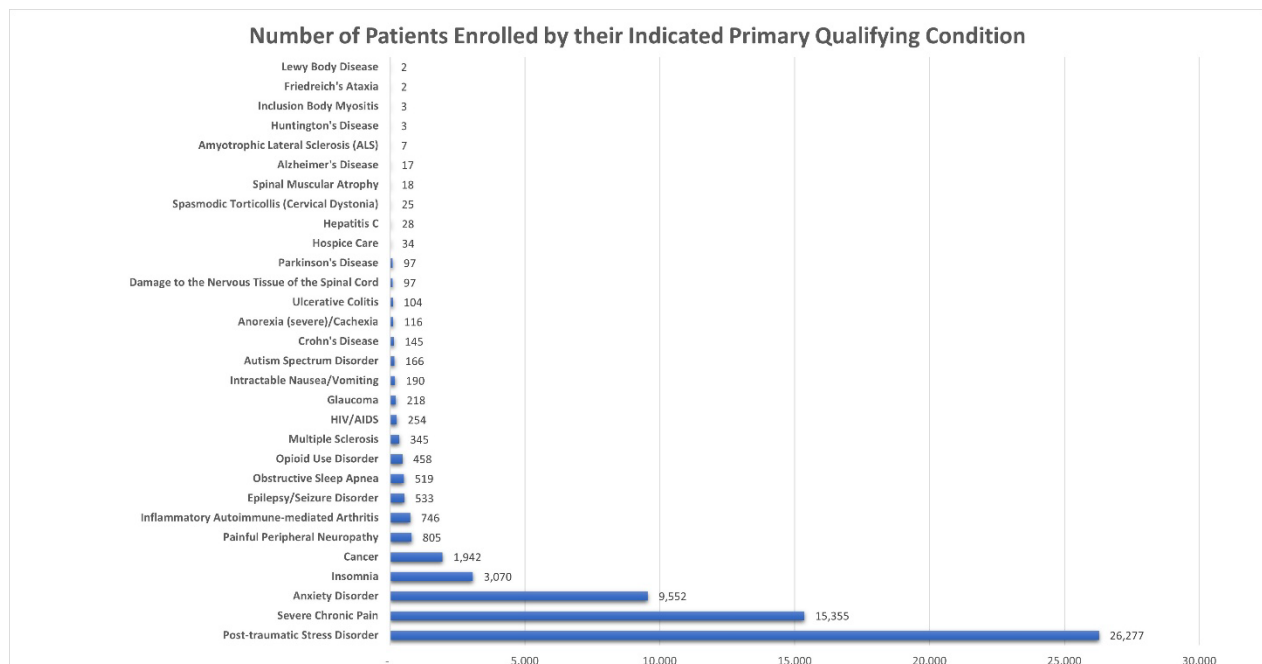

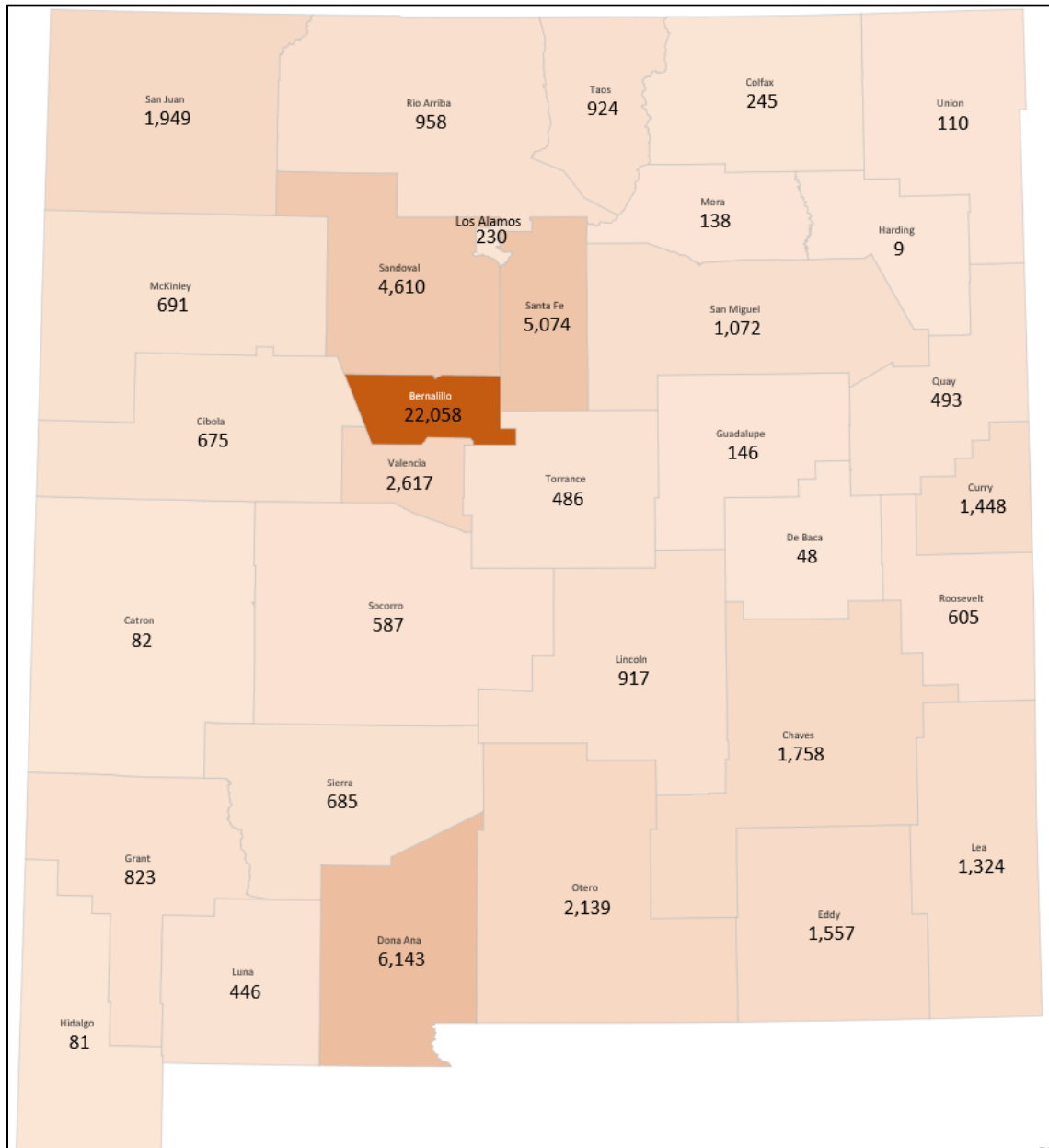

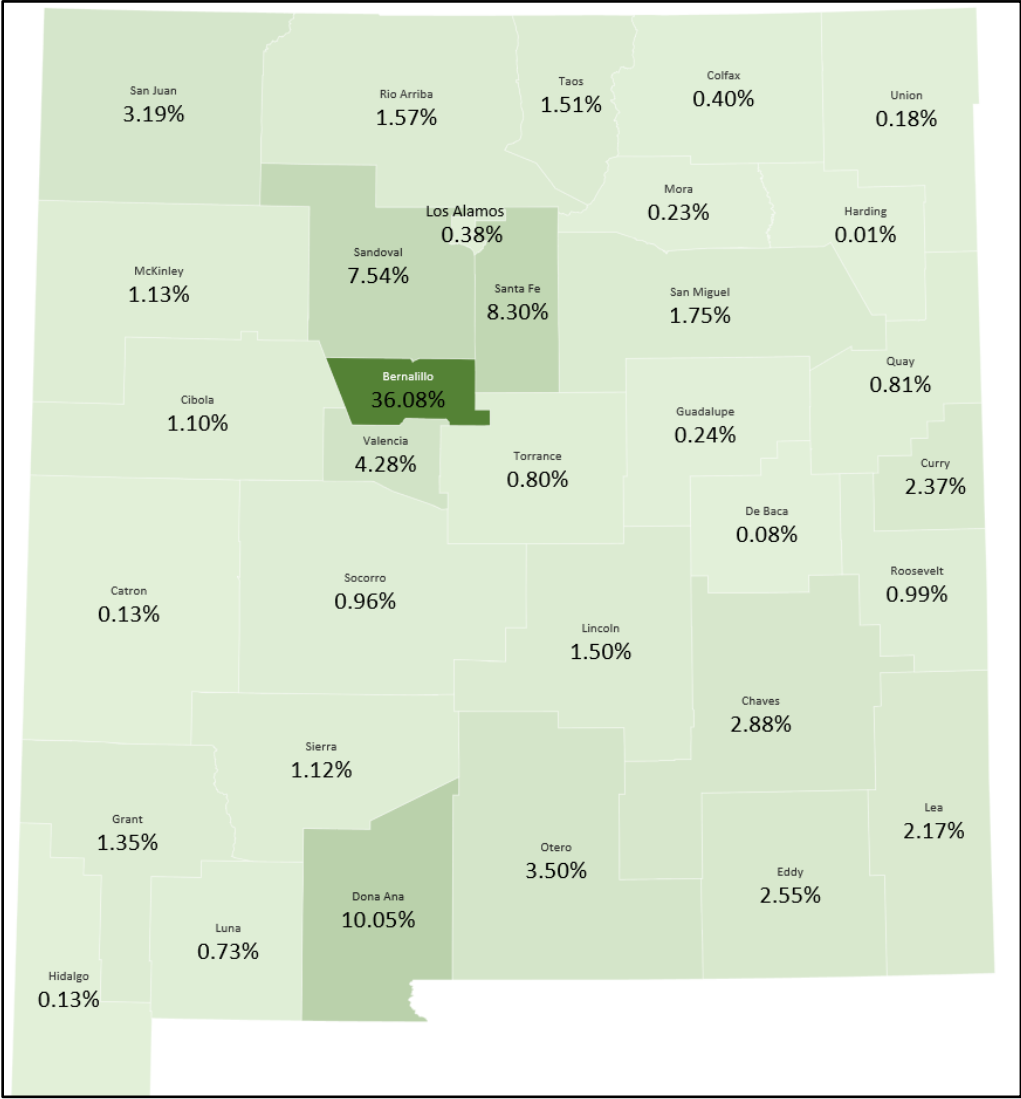

## Demographics

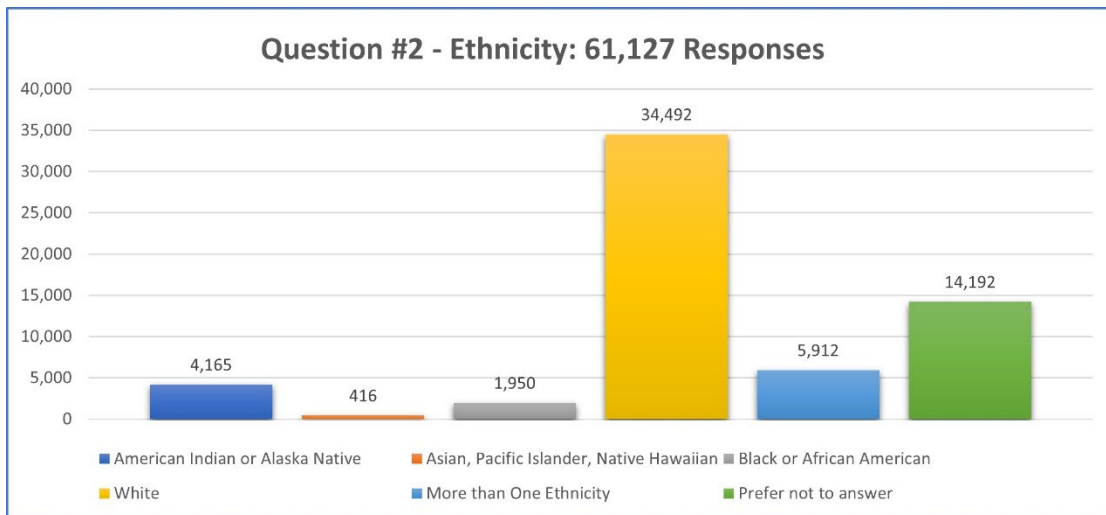

Ethnicity is asked as a two-part question when patients register. Here are the results:

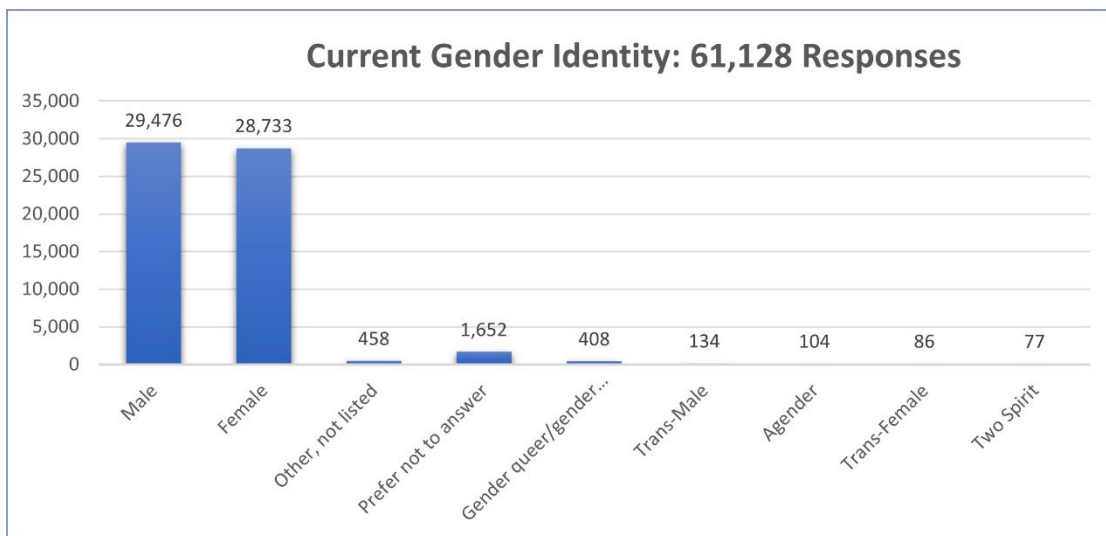

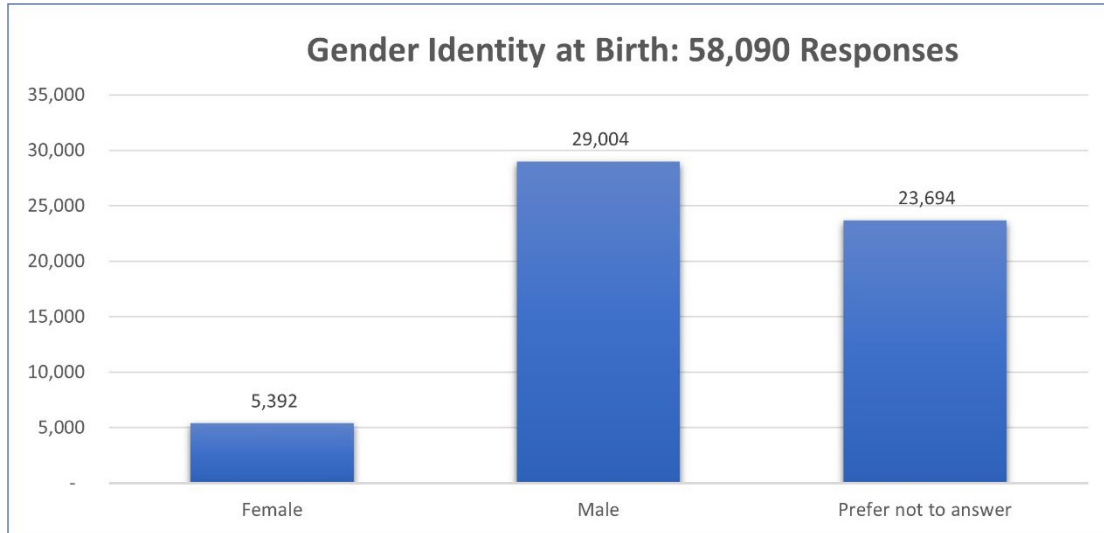

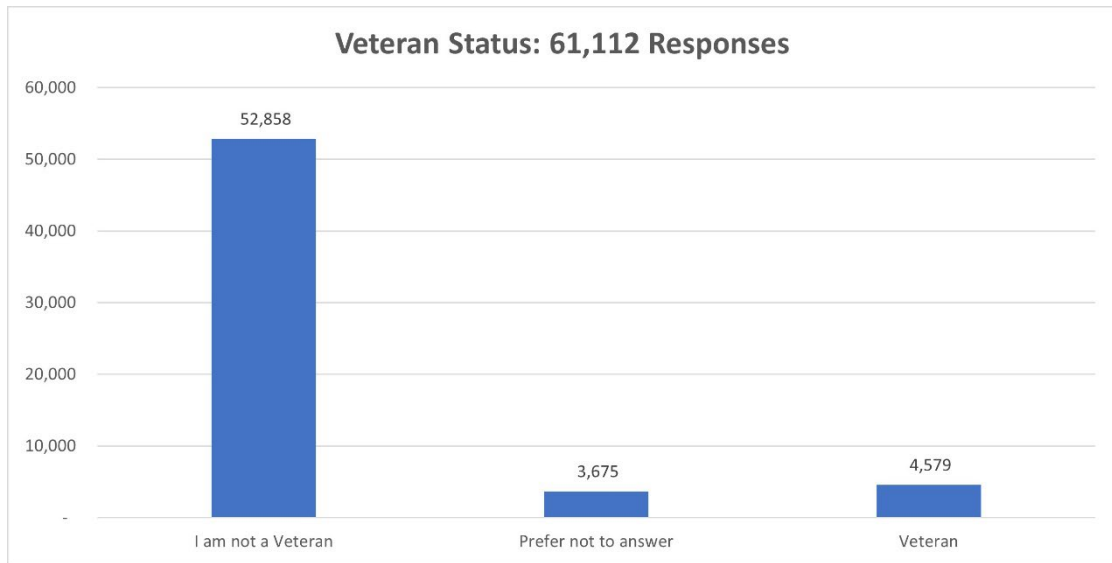

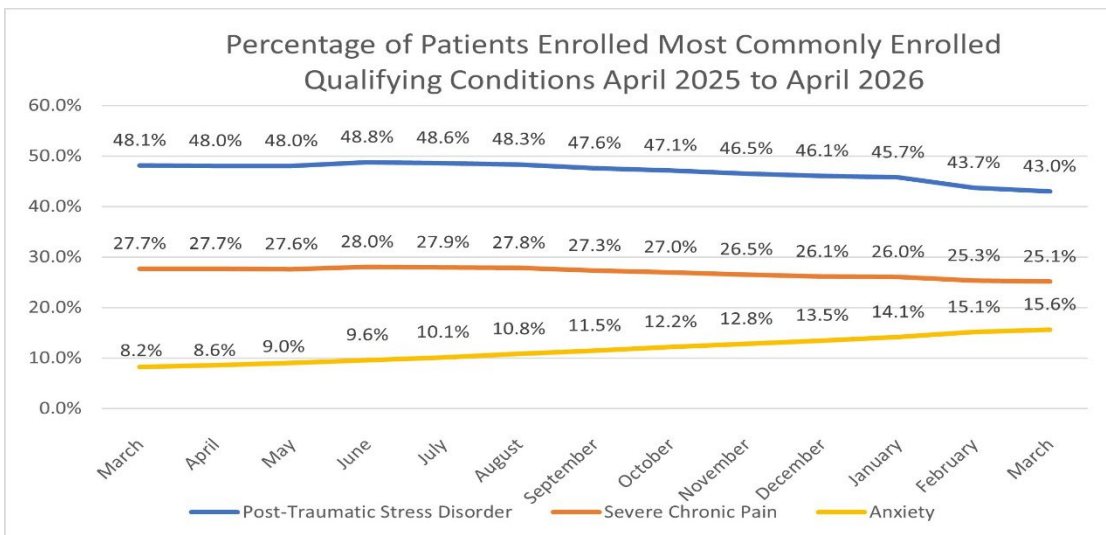

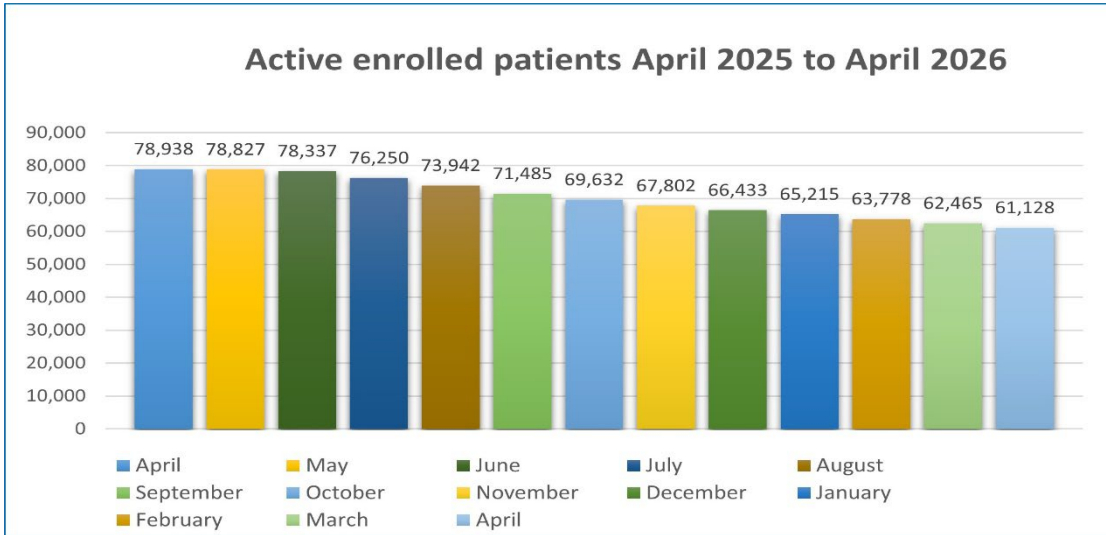
