

NOTICE OF PUBLIC HEARING

The New Mexico Department of Health (Department) will hold a public hearing on the proposed repeal and replacement of 7.34.4 MMAC, and the proposed amendment of Department rate sections 7.34.2. 7 and 7.34.3.7 NMAC. The hearing will be held on January 16, 2020 at 900 a.m. in A the auditorium of the Harold Rumels Building, located at 1190 St. Francis Drive in Santa Fe, New Mexico. This is the second public hearing concerning the proposed rule revisions.

The proposed rule revisions include new provisions in 7.34, 4 NMAC concerning reciprocity for individuals who hold proof of authorization to participate in the medical cannabis program of another state of the United States, the District of Columbia, a territory or commonwealth of the United States, or a New Mexico Indian nation, tribe or pueblo.

The proposed rule revisions also include provisions in 7.34, 4 NMAC for the establishment and operation of cannabis consumption areas for qualified patients, that are operated by licensed nonprofit producers.

The proposed rule revisions also include various modifications to the licensing requirements of 7.94 km (Ar. 2018).
